Joe Wever reviewed paperwork that he had when the Village of Salem put in the water system, with charts & figures for debt service, EDU's, etc. for the Board to see how everything was supposedly set up at that time.

## 2020 Budget-Review of Figures & Changes from 10/23/2019 meeting

**Review of Water Dep't.**-currently a deficit of-\$21,219 between Water Revenues & Water Appropriations, w/ appropriations being the larger figure! Raised the metered sales from a total of \$95,795 to \$105,950. After much discussion with Board, the following was decided:

Resolution #92-Motion made by Councilman Marcus Blanck, seconded by Councilman Harold Gilchrest, to use the Unexpended Fund Balance of \$21,219 & to add this amount to Line 485 Water District. This line will now read Appropriations & Provisions for other uses-\$219,062; Less Estimated Revenues of \$197,843; Less Unexpended Balance of \$21,219; Am't. to be raised by taxes \$0; passed unanimously by the following Board members: Marcus Blanck; Harold Gilchrest; Howard Law; Bruce Ferguson; Supervisor Evera Sue Clary Resolution #93-Motion made by Councilman Harold Gilchrest, seconded by Councilman Howard Law, to remove amount of \$4,000 under A9730.63-Bond Anticipation (BBT) under Debt Service Principal & to remove amount of \$460 under A9730.72-Interest-Bond Anticipation (roof); to add Line Item DA5130.21 under Machinery-Equipment (New) for \$10,000.00

<u>Resolution #94</u>-Motion made by Councilman Harold Gilchrest, seconded by Councilman Howard Law, to accept the Tentative Budget with the changes as stated in above <u>Resolution #93</u>, moving the same to the Preliminary Budget for 2020, setting the Public Hearing on the Salem & Shushan Fire Contracts & the 2020 Preliminary Budget for 7:00 p.m. on Wednesday, November 13, 2019 @ the regular monthly Town Board meeting. Passed unanimously 5-0 by the following Board members: Harold Gilchrest; Howard Law; Marcus Blanck; Bruce Ferguson; Supervisor Evera Sue Clary
